

Terms and Conditions For Tradelink 35th Anniversary Autumn Lucky Draw

1 Definitions

- 1.1 **"Tradelink"** means Tradelink Electronic Commerce Limited.
- 1.2 **"Announcement Day"** means the day on which the result of the Lucky Draw is announced, and such day shall be 9 October 2023.
- 1.3 **"Customers"** means registered customers of Tradelink.
- 1.4 **"Draw Day"** means the day on which the Autumn Lucky Draw is held, and such day shall be 3 October 2023.
- 1.5 **"Specified Services"** includes Import & Export Trade Declarations, Tradelink Road Cargo System, Certificate of Origin, Electronic Cargo Manifest, Dutiable Commodities Permit, Advance Filing Rules (AFR) to Japanese Customs and Automated Manifest Service (AMS) to US Customs.
- 1.6 **"Lucky Draw"** means the lucky draw to be held under the Program.
- 1.7 **"Participants"** means Customers who use any of the Specified Services during the Program Period, and on the Draw Day remain such status.
- 1.8 **"Program"** means the Tradelink 35th Anniversary Autumn Lucky Draw.
- 1.9 **"Program Period"** means the period from 1 July 2023 to 30 September 2023.

2 The Autumn Lucky Draw

- 2.1 The Autumn Lucky Draw will be held on 3 October 2023.
- 2.2 A Customer, who uses any Specified Service in any calendar month during the Program Period, shall automatically be entitled to ONE entry to the Lucky Draw regardless of the transaction volume of the Specified Services used or the fact that he/she has used more than one Specified Service during the month.
- 2.3 Lucky Draw entries Customers entitled for their usage of the Specified Services for the months during the Program Period will be accumulated. As such, under no circumstances shall a Customer be entitled to more than three entries to the Lucky Draw.
- 2.4 The results of the Lucky Draw shall be released on the Announcement Day via print on Sing Tao Daily and The Standard, and online via the Tradelink 35th Anniversary Autumn Lucky Draw website. Lucky Draw winners will also be notified individually by email.

3 Discretion

- 3.1 In the event of any dispute between a Customer and Tradelink under the Program, Tradelink's decision made at its sole discretion shall be final and conclusive.

- 4.1 Tradelink makes no warranty of whatever nature nor assumes any product liability in respect of the prizes of the Program.
- 4.2 Customers participating in the Program agree and accept that every prize awarded hereunder shall represent a transaction between its supplier and the winner Customer only, and further that they shall have no claim of whatever nature against Tradelink. No winner customers shall be entitled to cash refund in place of any awarded prize.

5 Personal Data

- 5.1 Personal data obtained from Customers for the Program is bound by our privacy statement.
- 5.2 Tradelink may arrange photo/video and/or other recordings during the Program and publish them for public information purposes. Participants shall inform Tradelink in writing prior to the Program if they do not wish to be included in photo/video and/or other recordings arranged by Tradelink.

6 Jurisdiction and Applicable Law

- 6.1 The laws of the HKSAR shall apply in the case of any dispute arising from or in connection with the Program or the terms and conditions hereof.
- 6.2 Tradelink and Customers participating in the Program irrevocably submit to the exclusive jurisdiction of the courts of the HKSAR.



6.3 If discrepancy or inconsistency exists between the English and Chinese versions of these terms and conditions, the English version shall prevail.
